ELIGIBILITY FOR CLUB TEAM CHAMPIONSHIP

Open to traditional golf clubs (that own their own course) which are members of the FSGA. The four team members must each be members of the club (traditional dues-paying golf membership).

ENTRY PROCEDURES

Incomplete and inaccurate entry forms will not be accepted. The entry fee must accompany the entry form. Make check payable to the FSGA. Failure to comply will result in immediate return of entry.

TOURNAMENT INFORMATION

Information concerning practice rounds, starting times, pairings and course assignments for tournament play will be assigned by the FSGA and posted on our website. The FSGA website is www.fsga.org.

CART INFORMATION

Cart fees for competitive rounds are included in the entry fee. However, players are responsible for practice round fees.

FORMAT

36 holes of stroke play stableford scoring. All players play eighteen holes each on the Harbor and River Courses. Each team total is derived from the total of the high 3 of the 4 stableford scores each round.

DIVISIONS

Regular and Senior Division. All team members must be age 55 or older as of November 12, 2011 to compete in senior division.

PRIZES

Gift certificates and trophy will be awarded to the winning teams. A low individual will be awarded and players in the top ten will receive points for the player of the year.

REFUNDS

Requests for refunds received prior to the entry closing date will be honored (less \$20 per entry administrative fee). Requests received after the closing date will be honored (less 50% of the entry fee). No requests will be honored within 48 hours of the first scheduled tee time.

HANDICAPS

Total team handicaps will be used for pairings only.
This is a gross event.

WITHDRAWALS

Players who have applied to participate in a FSGA event and wish to withdraw for any reason MUST notify the FSGA Office at (813) 632-FSGA (3742) prior to the event. If withdrawing on the day of the event, call the course you are assigned to play. Players who fail to follow this procedure will be listed as a NO SHOW.

RULES

Play will be in accordance with the USGA *Rules of Golf*, the current FSGA *Local Rules and Conditions of Competitions* and the FSGA *Pace of Play Policy* and applicable Local Rules. Questions shall be settled by the FSGA Rules Committee whose decisions shall be final.
